# 2024 Race Waiver & Release of Liability

## Participants must read and sign.

In consideration of being allowed to participate in any way in the related events and activities the undersigned:

**Acknowledges** and fully understands that he/she will be engaging in activities that involves risk of serious injury, including permanent disability or death, and severe social and economical losses which might result from not only his/her actions, inactions, negligence of others, the rules of play, the conditions of the premises or of any equipment used during the activity. Further, that there may be other risks not known or not reasonably foreseeable at this time.

**Assumes** all the foregoing risks and accepts personal responsibility for the damages following such an injury, permanent disability or death.

**Releases**, waives, discharges, and covenants not to sue Burkley Fitness Center, Jen Johnson Director, Jefferson Community Health Center, the respective administrators, directors, agents, and other employees and volunteers of the organization, other participants, sponsoring agencies, advertisers, State of Nebraska, State of NE Game & Parks, State of NE Department of Roads, Jefferson County Department of Roads, City of Fairbury, and, if applicable, other owners and leasers of premises used to conduct the event. All of these which are herein after referred to as "releasees" from the demands, losses, or damages on account of injury, including death, or damage to property, caused or alleged to be caused in whole or in part by the negligence of the releasee or otherwise.
